#### **Notes**

- Cancel FinClear account: Cancellation of your moomoo account will have the effect of cancelling your Chess-Sponsored FinClear account. You are not required to take any action during this account closing processes.
- 2. **Processing time:** To smoothly wrap up the account cancellation, please make sure that the above information has been filled out as required. We will process the account cancellation request within 1 to 5 business days of receiving your email.
- 3. Confirmation of account closure: Once your account is closed successfully, we will send an email notifying you of the status of the account closure. The email subject line will contain your moomoo ID, which you can use as proof of account cancellation.
- 4. **Re-Opening a moomoo account**: As per our company policy, if you close your current account, you will not be able to open another new trading account of the same type for the next six months from the date of account closure. (for example, if your individual account was successfully terminate on 1/01/2024, you will only be able to open a new individual account for the same person on or after 1/07/2024. However, you will still be able to open a moomoo entity account between 1/01/2024 and 31/07/2024.)
