How does Futu Inc. protect my personal information?	To protect your personal information from unauthorized access, we use a variety of measures designed to comply with federal law. Such measures include both proprietary and commercially available software and encryption programs. We also train our personnel on procedures and protocols to enhance protection against unauthorized access.	
How does Futu Inc. collect my personal information?	We collect your personal information when you open an account with us. During the account opening process, we may contact third parties to verify the personal information you provide to us. We may collect additional personal information about your financial accounts when you transmit payment for securities purchased through us.	
Why can't I limit all sharing?	Federal law only authorizes you to limit sharing with our affiliates and with third parties.  State laws and individual companies may give you additional rights to limit sharing. See below for more information.	
What happens when I limit sharing for an account I hold jointly with someone else?	[Your choices will apply to everyone on your account.	
Definitions		
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.	
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.	
Joint marketing	An agreement between nonaffiliated companies to jointly market their services or products to consumers. Futu Inc. does not engage in joint marketing with nonaffiliated companies.	

# Other important information

For California Residents. We will not share information we collect about you with nonaffiliated companies, except as permitted by law. For example, we may share information with your consent or to service your accounts. Among our affiliates, we will limit information sharing to the extent required by California law.

For Vermont Residents. We will not share information we collect about you with nonaffiliated companies, except as permitted by law. For example, we may share information with your consent or to service your accounts. We will not share information about your creditworthiness with our affiliates without your authorization or consent, but we may share information about our transactions or experiences with you with our affiliates without your consent.
